OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

By participating in the Electrolit & Casey's Cycling 2026 Sweepstakes (the "Sweepstakes"), you (an, "Entrant") unconditionally accept and agree to comply with and abide by these Official Rules (the "Official Rules") and the decisions of CAB Enterprise, Inc. (the "Sponsor") and US Sweepstakes & Fulfillment Co. (the "Sweepstakes Administrator"), which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

1. **SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes begins at 12:00:01 AM Eastern Time ("ET") on Wednesday, June 24, 2026 and ends at 11:59:59 PM ET on Tuesday, September 8, 2026 (the "Sweepstakes Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
2. **ELIGIBILITY:** The Sweepstakes is open to individuals who: (a) are legal residents of Arkansas, Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, and Wisconsin ("Eligible States"); (b) are the age of majority in their state of residence at the time of entry; and (c) are a Casey's Reward Account Member. **It is free to become a Casey's Reward Account Member. You can create a free account at <https://www.caseys.com/login?isAccountRegister=true>.** Void outside the Eligible States and wherever else prohibited by law. Employees of Sponsor, Sweepstakes Administrator, and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter.
3. **HOW TO ENTER:** There are two (2) ways to enter.
 - a. **Entry Method #1: Purchase Entry.** During the Sweepstakes Period, eligible customers who purchase two (2) 21oz Electrolit bottles as part of the 2 for \$5.50 Casey's offer (the "Offer") (a "Qualifying Purchase") and provide their phone number associated with their Casey's Reward Account upon checkout will automatically receive one (1) entry into the Sweepstakes (the "Purchase Entry"). *Qualifying Purchases that are cancelled, declined, returned or otherwise not completed will not result in an entry.* Qualifying Purchases must be made in a

single transaction, and while supplies last. Each Entry generated through a Qualifying Purchase associated with a Casey's Rewards account will be attributed to the authorized Casey's Rewards account holder and governed by the Casey's Rewards Program Terms and Conditions available at <https://www.caseys.com/rewards-terms-and-conditions>. **The Purchase Entry period is Wednesday, June 24, 2026 at 12:00:01 AM ET and Tuesday, September 8, 2026 at 11:59:59 PM ET.**

- b. Entry Method #2: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry.** To enter without purchase, clearly hand-print your full name, complete address, email address and phone number on a sheet of paper and mail that sheet of paper in an addressed envelope with proper postage to the following address to receive one (1) entry into the Sweepstakes (the "Mail-In Entry"): The **Electrolit & Casey's Cycling 2026 Sweepstakes**, PO Box 958, Social Circle, GA 30025-0958. **Each Mail-In Entry must be mailed separately and must be postmarked between Wednesday, June 24, 2026 and Tuesday, September 8, 2026, and received by Tuesday, September 15, 2026.** The envelope must include a return address in the upper left-hand corner that matches the Mail-In Entrant's street address.

Purchase Entry and Mail-Entry are collectively referred to herein as "Entry" or "Entries". Limit: Regardless of the method of entry, there is a limit of one (1) Entry per Entrant per day and a total of nine (9) Entries per Entrant during the Sweepstakes Period. Only the first Entry received per day from a given Entrant will be eligible. Subsequent entries, including entries submitted with an alternate email address, will be disqualified.

All methods of entry have an equal chance of winning. All Entries become the property of the Sponsor and will not be acknowledged or returned. Photocopied, illegible, or mechanically reproduced entries are not eligible. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries. 4. PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

- a. Grand Prize:** There is one (1) Grand Prize. One (1) Grand Prize winner ("Grand Prize Winner") will receive a bicycle. The total ARV of the Grand Prize is: \$800.
- b. First Prizes:** There are twenty (20) First Prizes. Each First Prize winner (each, a "First Prize Winner") will receive one (1) branded cycling jersey. **The ARV of each First Prize: \$68.**

The total ARV of all prizes available to be won: \$2,160. There is a limit of one (1) prize per Entrant. Odds of winning will depend upon the total number of eligible Entries received.

- 5. RANDOM DRAWING:** The potential winners will be selected in a random drawing on or about **Wednesday, September 16, 2026** from among all eligible Entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions with respect to the drawing are final.

6. WINNER NOTIFICATION & VERIFICATION:

- a. **Grand Prize Winner:** The potential Grand Prize Winner will be notified by the Sweepstakes Administrator, via email and/or phone, and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, and where allowable, a Publicity Release (collectively, the "Releases"). Noncompliance will result in disqualification and an alternate winner may be selected, at Sponsor's and Sweepstakes Administrator's option. The Grand Prize will be sent by the Sweepstakes Administrator within six (6) weeks of winner being verified.
- b. **First Prize Winners:** The potential First Prize Winners will be notified by the Sweepstakes Administrator via email and/or phone and will be required to confirm their full name, shipping address and date of birth within three (3) days of notification. Noncompliance will result in disqualification and an alternate winner may be selected, at Sponsor's and Sweepstakes Administrator's option. Prizes will be sent by the Sweepstakes Administrator within six (6) weeks of winner being verified.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these Official Rules, that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing, at Sponsor's and Sweepstakes Administrator's option. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of Entries to correspond to the number of prizes available to be awarded, Sponsor reserves the right to not award such prize(s).

7. **PRIZE CONDITIONS:** Prizes are not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any difference between the stated value and actual value of any prize will not be awarded. Any other incidental expenses on a prize not specified herein are the winner's sole responsibility. Sponsor will not replace any lost or stolen prizes or components of a prize. Sponsor and Sweepstakes Administrator are not liable for any errors in prize fulfillment or delivery. The specifics of a prize model, color and size awarded shall be solely determined by the Sponsor. Actual prizes awarded may vary from that depicted in advertising materials. Any prize depiction is for illustrative purposes only. Sponsor or Sweepstakes Administrator may ask any Entrant or potential winner to provide Sponsor with proof, to Sponsor's and/or Sweepstakes Administrator's satisfaction, that such party is the authorized account holder of the email address associated with the Entry. GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

- 11. DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Harris County, Texas and in any other court with jurisdiction over the parties. Entrants should be aware that in arbitration, there is no judge or jury, the rules of evidence and discovery are more limited than in court, and the arbitrator's decision and award is final and binding, with limited exceptions. Judgment on the award may be entered in any court with jurisdiction. The parties agree that any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS, except that the Released Parties retain the right to seek injunctive relief. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Harris County, Texas. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Harris County, Texas. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of Entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
- 12. PRIVACY:** As a condition of entering the Sweepstakes, each Entrant gives consent for Sponsor to obtain and deliver their name, address and other information to third parties, including Sweepstakes Administrator.
