OFFICIAL RULES

1. **SWEEPSTAKES PERIOD:** Entry into the 2026 DEW DAY & MOUNTAIN DEW BAJA BLAST AT CASEY'S SWEEPSTAKES (the "Sweepstakes") begins at 12:00:00 a.m. (midnight) Central Time ("CT") on February 4, 2026 and ends at 11:59:59 p.m. CT on March 3, 2026 (the "Sweepstakes Period").
2. **HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods:
 - a. **PURCHASE ENTRY:** Purchase the required products of any *Dew® Day Offer* communicated on the Casey's Reward App (the "Qualifying Purchase") at a participating Casey's or Goodstop retail location during the Sweepstakes Period, to automatically receive one (1) entry into the sweepstakes (an "Entry"). Entrant must be a Casey's Rewards Account Member to be able to redeem a *Dew® Day Offer*. Qualifying Purchase must be made in a single transaction, while supplies last. Limit of (1) Entry per day, not to exceed a total of nine (9) Dew Day offer Entries throughout the Sweepstakes Period, regardless of how many *Dew® Day Offers* are posted or redeemed. Sponsor may disqualify any Entries from a person that exceeds the maximum permitted Entries. Any attempt to submit more than the maximum number of Entries using multiple or different email addresses, identities, accounts, or any other methods will void that entrant's Entry(ies). Entries generated by robotic, programmed script, macro, or by other automated means will be disqualified. No other forms of entry are valid other than those set forth above. Each Entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced Entries will be accepted. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. (midnight) CT and ending at 11:59:59 p.m. CT. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

In the event of a dispute over the identity of a potential winner, an Entry will be declared made by the authorized account holder of such email address or wireless phone number associated with the Casey’s Rewards Account or submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number.
