

# National Pizza Party Day Giveaway

## OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** By participating in the National Pizza Party Day Giveaway (“**Promotion**”), entrant accepts and agrees to these Official Rules and the decisions of Casey’s Retail Company (“**Sponsor**”), which shall be final in all matters. The Promotion is in no way sponsored, endorsed, or administered by, or associated with, Instagram or Facebook. All federal and state laws apply.

2. **HOW TO ENTER:** Beginning on May 15, 2024, at 8:00 a.m. Central Standard Time through May 16, 2024, at 8:00 a.m. Central Standard Time, enter in one of the following ways:

- Follow @caseys on Facebook; tag a friend and comment on the National Pizza Party Day Giveaway post.

Limit one entry per person. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times by using multiple email addresses, identities, or devices.
