

## **Throne Sport Coffee Sweepstakes – Casey’s Signed Football February 2025**

### **Official Rules, Terms and Conditions:**

By entering into this sweepstakes, you accept the terms and conditions set forth in these Official Rules. You confirm that you are at least 18 years old and have reached the age of majority in your jurisdiction of residence at the time of opt-in (19 in Alabama and Nebraska; 21 in Mississippi). By entering, you further agree to sign up to receive newsletters and special offers from Throne Sport Coffee has provided the prizes to the sweepstakes, is sponsoring the sweepstakes and is responsible for operating the Sweepstakes. No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning. The Sweepstakes is subject to federal, state, municipal, and local laws and regulations and is void where prohibited. **Eligibility:** This sweepstakes is open to anyone who is at least eighteen (18) years of age and has reached the age of majority in their jurisdiction of residence at the time of opt-in (19 in Alabama and Nebraska; 21 in Mississippi) and is a resident of AR, IL, IN, IA, KS, KY, MI, MN, MO, NE, ND, OH, OK, SD, TN, TX, or WI, and has a valid email address and physical mailing address within the above jurisdictions, and who are Casey’s Rewards members. Employees, family member and members of employees’ household, independent contractors, interns, officers, directors, subsidiaries and agents of Sponsor and any associated companies are not eligible to enter.

**Agreement to Official Rules:** By entering the sweepstakes, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules, (b) subscription to the email lists of Throne Sport Coffee, (c) Sponsor’s decisions, which are final and binding. Winning the prize is contingent upon fulfilling all requirements set forth herein.

**Entry Period:** The Sweepstakes begins on February 4, 2025, 9:00am EST and ends on February 9, 2025 at 11:59pm EST (“Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official timekeeping device for the Sweepstakes.

**How to Enter:** During the entry period, you may enter the Sweepstakes by opening the Casey’s Reward App (which is available for download for free in most app stores) and scrolling to the “Throne Sport Coffee Patrick Mahomes Autograph Football Sweepstakes” link and filling out the on-screen entry form.. There is a limit of one (1) entry per person for the entire promotion. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion.

**Drawing:** After the Entry Period, on or about February 10, 2025, Sponsor will select a total of one (1) grand prize winner in a random drawing of all eligible entries received. The odds of being selected depend on the number of entries received.

**Notification and Requirements of Potential Winner:** Sponsor will attempt to notify the potential winners within five (5) business days of the drawing by direct message. If a potential winner does not respond within seven (7) calendar days after the notice is sent, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received.
