

Casey's Pizza for a Year – CEFCO Sweepstakes

OFFICIAL RULES

OVERVIEW: The Casey's General Store Pizza for a Year Giveaway (the "Promotion") is a campaign, which involves purchasing any large pizza through Casey's Rewards to earn an entry for free pizza for a year.

1. ELIGIBILITY: The Promotion is open only to legal U.S. residents of TX, who are at least eighteen (18) years old at the time of entry. Employees of Casey's Retail Company ("Sponsor") and their parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parents, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes participant's full and unconditional agreement to these Terms and Conditions and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. SPONSOR AND ADMINISTRATOR: Casey's Retail Company, One SE Convenience Blvd. Ankeny, IA 50021.

3. TIMING: Eligible purchases between February 7th, 2025 at 12:00 p.m. Central Time ("CT") and April 1st, 2025 at 11:59 p.m. CT (the "Promotion Period") will count as entries for the promotion.

4. HOW TO PARTICIPATE:

Entry Method 1: During the promotion period, Rewards members may order any large Casey's pizza and earn one entry into the promotion per transaction. If a participant is not a Casey's Rewards member, they may visit www.caseys.com/rewards to sign-up for free.

Entry Method 2: To enter the Sweepstakes without using or signing up for a Casey's Rewards account, hand print "**ATTN-Pizza for a Year 2025 Sweepstakes-Entry**" along with your name, address, city, state, zip code, telephone number, and email address (optional) on a 3x5 card and mail it to: "**ATTN-Pizza for a Year 2025 Sweepstakes-Entry**", One SE Convenience Blvd, Ankeny, IA 50021. Mail-in entries must be postmarked within the "Mail-In Entry Postmark Date Period" and be received by the "Mail-In Entry Due Date" listed below to be eligible for the corresponding Prize and Entry Period's Drawing. Enter as often as you wish; however, limit one (1) entry per outer mailing envelope. Photocopied entries are not allowed. No responsibility is assumed by Casey's for lost, late, illegible, incomplete, stolen, postage-due or misdirected mail. All mail-in entries become the property of the Casey's and will not be returned to entrant.

Mail-in Entries must be postmarked between February 7, 2025, and April 1, 2025, the “Mail-in Entry Postmark Date period”; and received 24 hours prior to each drawing date and no later than April 1, 2025, the “Mail-in Entry Due Date,” to be eligible for entry.

5. PRIZES AND RESTRICTIONS:

Prize winners will be selected in random drawings by the Administrator from among all eligible entries received. One (1) total prize will be awarded during one drawing session. Draw date is on or around April 15, 2025. Entries eligible for one drawing will remain eligible for all subsequent drawings. The odds of winning a prize depend on the number of eligible entries received during the Promotion Period.

One (1) participant will win free pizza for a year, fulfilled as 24 offers for a free large pizza. The prize will be distributed through the winner’s Casey’s Rewards account in the form of 24 offers for one large pizza each. The offers will be loaded to the account one at a time, and a new offer will be reloaded into the account each time another is redeemed. Each offer must be redeemed one transaction at a time

The offers will available through the authorized account until winner redeems a total of 24 free pizzas, or until April 1, 2026, whichever comes first. No warranty, representation or guarantee, express or implied, in fact or in law, relative to the use of the prize, whether proper or improper, is made by Casey’s, and it is being provided “as-is.” Prizes may not be sold, assigned, transferred, changed, exchanged, substituted or redeemed for cash.

6. WINNER NOTIFICATION: Potential winners will be notified from the Administrator by email notification within three (3) business days of drawing. Verified winners will have their prize added directly to their Casey’s Rewards account and ready for immediate use.

Winners are responsible for all taxes and fees associated with prize receipt and/or use, and may receive an IRS Form 1099 reflecting the final actual value of the prize.

7. RELEASE: By participating in the Promotion, participant agrees to release and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company’s officers, directors, employees and agents (collectively, the “Released Parties”) from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize.

8. GENERAL RULES. Casey’s reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Promotion, as determined by Casey’s in its sole discretion and if terminated, at its discretion, select the potential winners from all eligible, non-suspect entries received prior to termination. Casey’s reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or

disruptive manner. Casey's failure to enforce any term of the Official Rules shall not constitute a waiver of that provision.

Participation in the Promotion constitutes your full and unconditional agreement to and acceptance of the Official Rules and to Casey's decisions in all matters related to the Promotion, which are final and binding at its sole discretion.

Liability for any irregular entry or errant winning announcement will be limited to replacement with another chance to win. If through occurrence of, production, notification, computer, electronic or any errors whatsoever, more winning notifications are offered and distributed than those prize quantities offered in the Official Rules, no more than the actual number of prizes per these Official Rules will be awarded. Should such a situation occur, winners will be determined in a random drawing from among all submitted eligible and verified winning prize claims for the specific prize at issue.

Winners acknowledge that Sponsor and all other businesses concerned with this Promotion and their agents do not make, nor are in any manner are responsible for any warranty, representations, expressed or implied, in fact or in law, relative to the quality, conditions, fitness or merchantability of any aspect of a prize, except that each prize shall be subject to its manufacturer's standard warranty if applicable.
