

Stamford Sport Brands, LLC Sweepstakes – Casey’s Home Gym **Sweepstakes**

Official Rules, Terms and Conditions:

By entering into this sweepstakes, you accept the terms and conditions set forth in these Official Rules. You confirm that you are at least 18 years old and have reached the age of majority in your jurisdiction of residence at the time of opt-in (19 in Alabama and Nebraska; 21 in Mississippi). Stamford Sport Brands, LLC, dba Throne Sport Coffee, has provided the prizes to the sweepstakes, is sponsoring the sweepstakes and is responsible for operating the Sweepstakes. No Purchase Necessary. - **How to Enter:** Purchase any two (2) or more 11fl. oz. single cans of Throne SPORT COFFEE product at 2/\$6.50 Member Deal price from a participating Casey’s location in a single transaction during the Entry Period and scan your applicable Casey’s Rewards app (the “App”) member barcode or enter your phone number associated with your Casey’s Rewards at checkout when making your qualifying purchase. You will only receive one (1) Sweepstakes entry regardless of the number of cans of Throne SPORT COFFEE product purchased in excess of two (2). Registration for Casey’s Rewards is free online at <https://www.caseys.com/rewards> or in the App. The App is free and can be downloaded through the Apple App Store or Google Play.

- **Mail In:** To enter without purchase.
