Sponsor's designated database clock will be the timekeeper for this Sweepstakes. Entry in the Sweepstakes does not constitute entry into any other sweepstakes or contest. By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, 900 Long Ridge Road, Building #2, Stamford, CT 06902, and COHEN-FRIEDBERG ASSOCIATES, LLC, E.
