Sweepstakes begins at 12:00.00 a.m. Central Time (CT) on December 1, 2023 and ends December 24, 2023 at 11:59:59 p.m. (CT) ("Sweepstakes Period").

The 24 Days of Casey's Sweepstakes ("Sweepstakes") is open to legal U.S. residents of the IA, IL, IN, KY, TN, AR, OK, MI, OH, MO, KS, NE, SD, ND, MN, TX and WI states who are 18 years or older at the time of entry (19 in NE).
