Casey's TKO Takeover Sweepstakes

OFFICIAL RULES

OVERVIEW: The Casey's TKO Takeover (the "Sweepstakes") is a campaign, which involves saving an offer through Casey's Rewards to earn an entry for free pizza, Casey's gift cards, and Visa Gift cards. 4. HOW TO PARTICIPATE:

<u>Entry Method 1:</u> During the Promotion Period, Rewards members may enter the Sweepstakes by saving one (1) offer per each TKO event: Ultimate Fighting Championship (UFC), World Wrestling Entertainment (WWE), or Professional Bull Riders (PBR).

Offers available to save during Promotion Period:

- 2. Win a PBR Knockout Watch Party
- 3. Win a WWE Raw Watch Party

There is a limit of one (1) entry per person per event, up to three (3) total entries for the entire promotion. If a participant is not a Casey's Rewards member, they may visit www.caseys.com/rewards to sign-up for free.

Entry Method 2: To enter the Sweepstakes without using or signing up for a Casey's Rewards account, hand print "ATTN-Casey's TKO Takeover 2025-Entry" along with your name, address, city, state, zip code, telephone number, and email address (optional) on a 3x5 card and mail it to: "ATTN-Casey's TKO Takeover 2025-Entry", One SE Convenience Blvd, Ankeny, IA 50021. Mail-in entries must be postmarked within the "Mail-In Entry Postmark Date Period" and be received by the "Mail-In Entry Due Date" listed below to be eligible for the corresponding Prize and Entry Period's Drawing. Enter as often as you wish; however, limit one (1) entry per outer mailing envelope. Photocopied entries are not allowed. No responsibility is assumed by Casey's for lost, late, illegible,
